ADDITIONAL DETAILS

How to make a reservation: Please fill out the reservation form from the Extra Touch website (eXtraTouchTours.com) and email it to reservations@extratouchtours.com. For questions prior to your reservation, please call 712-317-9002.

Deposit: \$600 non-refundable deposit per person. Final Payment due April 17, 2026. Not included: airfare, airline baggage fees, optional tours in port, travel insurance/cancellation protection, room incidentals, items of personal nature, required documentation such as passport & VISA fees, costs for vaccinations (if needed), and other miscellaneous expenses not outlined in the tour itinerary.

Documentation: A valid U.S. passport book that is valid at least six (6) months from the date of your return is required for this cruise. A copy of your passport must be sent in with your reservation.

Smart Phones/Email: Princess cruises will ask you to do some registration requirements online. It is highly recommended you have a smart phone for this cruise and an email for pre-cruise communication.

CANCELLATION POLICIES – All cancellation fees are based on 'per person.'

Travel Insurance: We recommend travel insurance to protect your payments from cancellation fees. Your trip investment is worth protecting, and travel insurance is the best way to safeguard against unexpected events that can prevent you from traveling and being assessed significant cancellation, interruption, medical, or other fees. Shore Excursions/Tour Preparation: Tour communications will be sent to assist with booking optional shore excursions, which are at additional cost, and to communicate any additional preparations for your trip. It is important that we have an email address for these communications.

Final Documents: Approximately three weeks prior to your departure date, you will receive your final documents. Departure times, a hotel list, detailed tour itinerary, medical form, and luggage tags will be included.

Changes in Tour Price: Tour prices in this publication are effective as of April 1, 2024, and are subject to fluctuation due to the U.S. dollar exchange rates and energy rates. Our best effort has been made to publish this information as accurately as possible. The right is reserved to change tour rates as deemed necessary by current currency, fuel price fluctuations, taxes, typographical errors, or other reasons, etc. Due to the volatility of airfares and flight schedules, tours utilizing air transportation are subject to change both in price and routing. Submitting your deposit is an acknowledgment of your agreement to these terms.

Changes in Itinerary: The ports, events, attractions, restaurants, and hotels scheduled in your tour are subject to change. Every effort will be made to preserve the original quality of attractions and hotels when circumstances necessitate a substitution.

Baggage Allowance: Portage for one suitcase (per person) is included in the tour price. Due to limited motorcoach capacity, your single bag should have dimensions not exceeding 30" x 21" x 11" and weigh no more than 50 lbs. Small carry-on bags are allowed and are your responsibility. Most airlines assess a baggage fee. This fee is not included in the tour price and is paid for at airport check-in.

Single Travelers: Single rates are available upon request.

Inspiration and Faith: Due to tour schedules, we are unable to make any special provisions for church worship services. Many tour hosts share a "Thought for the Day," verses of inspiration, devotionals, or a short prayer to start the day. If possible, we will have a casual worship service onboard the ship on Sundays.

Special Needs: Please notify us of any special needs at the time of reservation. We will make all reasonable efforts to assist with your travel arrangements. However, it is strongly recommended that a traveling companion come along to help with any special needs of anyone with a disability. Extra Touch Hosts have responsibilities for the entire group and can't provide one-on-one care.
