Deposit: \$600 per person. Final Payment due November 15, 2024.

Documentation: A valid U.S. passport book that is valid at least six (6) months from the date of your return is required for this cruise. A copy of your passport must be sent in with your reservation.

Most airlines assess a baggage fee. This fee is not included in the tour price and is paid for at airport check-in.
